In particular, I and the Customer authorise the Company to:

(a) obtain from any credit reference agency information concerning the credit history of the Customer and any guarantor, director or shareholder of the Customer;

(b) disclose credit related information to any credit reference agency for its database concerning the Customer and any guarantor, director or shareholder of the Customer;

(c) use the credit reporting services of any credit reference agency on a continuing basis, at the Company's discretion, concerning the credit worthiness of the Customer and any guarantor, director or shareholder of the Customer; and

(d) send promotional material or information about the Company's products and services to the Customer (except where the Customer has advised the Company in writing that it does not want to receive such information).

4) The Customer agrees that it remains liable to pay the full amount owing on its credit account, even if that amount exceeds any approved credit limit.
